WHEREAS, Scozzari has also agreed in writing, pursuant to N.J.S.A. 18A:18A-36a, to extend the period for the Board to consider and award a contract based on the Alternate #5, additional 5th Grade Classrooms, in the amount of \$932,793.00, until ninety (90) days from the date of the base bid contract award:
